He obtained Master of Law – Comparative Public Law degree in 2024 at the Faculty of Law of the International University of Sarajevo, with the average grade of 3.73 and ECTS of 60. He is enrolled since 2025 in the PhD Degree studies in “European Law” at the Faculty of Law, Dzemal Bijedic University, Mostar, Bosnia and Herzegovina.

## 2. REVIEW OF THE APPLICATION PACKAGE AND COMMITTEE’S EVALUATION

### PREGLED DATIH DOKUMENATA I OCJENA KOMISIJE

Muhemmed Huzeyfe Küçükaytekin graduated from the Faculty of Law at the International University of Sarajevo in 2021, obtaining the title of Bachelor of Laws with an average grade of 3.28 and 249 ECTS. He subsequently earned a Master of Laws (LL.M.) in Comparative Public Law at the same faculty in 2024, with an average grade of 3.73 and 60 ECTS, thereby fulfilling the requirement of completing the second cycle of studies or its equivalent with at least 300 ECTS credits and minimum average grade of 3.5, needed for appointment to the academic title of Senior Assistant. Since 2025, he has been enrolled in PhD studies in “European Law”, at the Law Faculty of the “Dzemal Bijedic” University, Mostar. The candidate submitted additional published works with his application, which the Committee took note of but did not evaluate separately, as they do not constitute legal requirements for appointment to the academic title of Senior Assistant.

*Muhemmed Huzeyfe Küçükaytekin diplomirao je na Pravnom fakultetu Internacionalnog univerziteta u Sarajevu 2021. godine, stekavši zvanje Bakalaureat prava, sa prosječnom ocjenom 8,38 i 249 ECTS bodova. Magistrirao je na Pravnom fakultetu Internacionalnog univerziteta u Sarajevu, na studijskom programu „Komparativno javno pravo“ 2024. godine, sa prosječnom ocjenom 9,17 i 60 ECTS bodova, čime ispunjava uslove završetka drugog ciklusa studija ili njegovog ekvivalenta sa najmanje 300 ECTS bodova i minimum prosjeka ocjene 8, potrebnih za izbor u naučnonastavno zvanje višeg asistenta. Od 2025. godine upisan je na doktorski studij „Evropsko pravo“ na Pravnom fakultetu Univerziteta „Džemal Bijedić“ u Mostaru. Kandidat je uz prijavu dostavio i dodatne objavljene radove, koje je Komisija uzela u obzir, ali ih nije posebno vrednovala, budući da budući da ne predstavljaju zakonske uslove za izbor u zvanje višeg asistenta.*




