Pursuant to Article 107 paragraph (3) of the Law on Higher Education ("Official Gazette of Sarajevo Canton" 33/17) and based on the Decision of the Council of the Faculty of Law, number: IUS-FLW-15-1845/20 dated September 29th, 2020, acting in accordance with the submitted Report from Administrative Service no. IUS-FLW-15-1831-1/20 (attached to this Report), the Committee for preparation of proposals for the appointment to academic title of Assistant Professor, composed of:

1. **Prof. Dr. Džemal Najetović**, full professor at the Faculty of Law of the University of Travnik – appointed for the scientific field of State and International Public Law (chairman);
2. **Doc. Dr. Maja Pločo**, assistant professor at the Faculty of Legal Sciences of the University of Vitez - appointed for the scientific field of State and International Public Law Civil Law (member);
3. **Doc. Dr. Ena Kazić**, assistant professor at the Faculty of Law of the International University of Sarajevo - appointed for the scientific field of Criminal Law (member).

**A – Biographical information and academic degree of candidate**  
**Biografski podaci i akademski stepen**

Dr. Kenan Ademović was born in Sarajevo, Bosnia and Herzegovina, in 1971. He received his Ph.D. degree in European Constitution and perspective of BIH towards European integrations (*magna cum laude*) at the University of Sarajevo, Faculty of Law (2014), where he also obtained a master degree in 1997, „Granice u međunarodnom pravu sa posebnim osvrtom na BIH“. Dr. Kenan Ademović obtained another master degree in European Studies, “Human rights in contest of Islamic and European dialogue”, 2002. During the Spring

semester 2020, Dr. Kenan Ademović served as an adjunct instructor at the International University of Sarajevo and has taught a graduate course in comparative constitutional law. In addition to his academic engagements, since June 2013, Dr. Kenan Ademovic is a practicing attorney and a member of the Bar of the Federation BiH. He has published several articles in reputable academic journals and spoke as a panelist at international conferences. He is fluent in English language, and Bosnian is his mother tongue. Her areas of interest are state and international public law, business law etc.

Dr. Kenan Ademović je rođen 1971 godine u Sarajevu, Bosna i Hercegovina. Zvanje doktora pravnih nauka stekao je 2014., i odbranio je temu pod naslovom „Evropski ustav i perspektive BiH ka evropskim integracijama“ na Univerzitetu u Sarajevu, Pravni fakultet gdje je 2002. godine stekao i zvanje magistra pravnih nauka i odbranio temu „Granice u međunarodnom pravu sa posebnim osvrtom na BIH“. Radio je kao predavač na Internacionalnom univerzitetu u Sarajevu u ljetnom semestru 2020. godine. Pored akademskog angažmana, od juna 2013. godine Dr. Kenan Ademović je advokat i član advokatske komore FBiH. Do sada je objavio veći broj referentnih naučnih radova u prestižnim međunarodnim časopisima, te prezentirao na međunarodnim konferencijama. Tečno govori i piše na engleskom jeziku, dok je bosanski jezik njegov maternji jezik. Njegova polja interesovanja su državno i međunarodno javno pravo, poslovno pravo itd.
