**1. BIOGRAPHICAL INFORMATION AND ACADEMIC DEGREE OF THE CANDIDATE  
BIOGRAFSKI PODACI I PODACI O NAUČNOM STEPENU KANDIDATA**

Dr. Sci. Ena Kazić-Çakar was born in Sarajevo in 1987. Since 2018, she has been employed as an Assistant Professor at the Faculty of Law of the International University in Sarajevo, at the Department of Criminal Law. She completed her First Cycle of Studies at the Faculty of Law of the University of Sarajevo in 2009, with an average GPA 3.87. As the best student in her cohort, she was awarded with the Golden Badge of the University of Sarajevo. By defending her final thesis, she completed her studies at the Second Cycle of Studies at the Faculty of Law of the University of Sarajevo, at the Department of Criminal Justice, majoring in Criminal Law. For the achieved average GPA 4.0, she was awarded another Golden Badge of the University of Sarajevo. She obtained her Ph.D. degree from the Faculty of Law of the University of Sarajevo, Criminal Law Cathedra, on February 12, 2018. After completing her BA studies, dr. Sci. Kazić-Çakar practiced law at the Court of Bosnia and Herzegovina, and afterwards gained extensive work experience at higher education institutions. She perfects the acquired knowledge by participating in domestic and international scientific and professional conferences, world-renowned summer schools,

seminars and congresses. She is a member of the Research Commission of the European Forum for Restorative Justice. She speaks four foreign languages.

Dr. Sci. Ena Kazić-Çakar je rođena u Sarajevu 1987. godine. Od 2018. godine je zaposlena kao docentica na Pravnom fakultetu Internacionalnog Univerziteta u Sarajevu, na krivičnopravnoj katedri. Studij na Prvom ciklusu studija na Pravnom fakultetu Univerziteta u Sarajevu, okončala je 2009. godine, sa prosjekom ocjena 9,87. Za postignuti uspjeh je kao najbolji student generacije, nagrađena Zlatnom značkom Univerziteta u Sarajevu. Održanom završnog rada, okončala je studij na Drugom ciklusu studija na Pravnom fakultetu Univerziteta u Sarajevu, na Krivičnoj katedri, smjer Krivičnopravni. Za postignuti prosjek 10,00, kao najbolji student generacije, nagrađena je još jednom Zlatnom značkom Univerziteta u Sarajevu. Doktorirala je na Pravnom fakultetu Univerziteta u Sarajevu, na Krivičnoj katedri, smjer Krivičnopravni, dana 12.02.2018. godine. Dr. Sci. Kazić-Çakar je po završetku studija radila u praksi, na Sudu Bosne i Hercegovine, a potom je stekla i višegodišnje iskustvo rada na visokoškolskim ustanovama. Stečeno znanje usavršava učešćem na domaćim i međunarodnim naučnim i stručnim konferencijama, svjetski priznatim ljetnim školama, seminarima i kongresima. **PROPOSAL AND RATIONALE**  
**PRIJEDLOG I OBRAZLOŽENJE**

The Committee has thoroughly reviewed and considered the application submitted within public vacancy call, published on August 22<sup>nd</sup>, 2022 by the Faculty of Law in the newspaper "Nezavisne novine" and on the web page of IUS, and established that Dr. Sci. Ena Kazić-Çakar met the public call conditions for an appointment to scientific-teaching title of associate professor from the Law on Higher Education. The Committee had the task to propose one candidate for appointment based on the assessment of the scientific work and publications achieved after the election period spent in the rank of assistant professor.

Komisija je detaljno pregledala i razmotrila aplikaciju po prijavi na javni konkurs, objavljen dana 22.8.2022. godine od strane Pravnog fakulteta u dnevnom listu "Nezavisne novine" i na web stranici IUS-a, te je utvrdila je da je dr.sci. Ena Kazić Çakar ispunila uslove iz navedenog konkursa za imenovanje u nastavno-naučno zvanje vanrednog profesora shodno Zakonu o visokom obrazovanju Kantona Sarajevo. Komisija je imala zadatku da predloži jednog kandidata za izbor u zvanje na osnovu procjene naučno-istraživačkog rada i publikacija nakon izbornog perioda provedenog u zvanju docenta.

Prema Zakonu o visokom obrazovanju Kantona Sarajevo, uslovi za izbor u zvanje vanrednog profesora su: "proveden najmanje jedan izborni period u zvanju docenta, najmanje pet naučnih radova objavljenih u priznatim publikacijama koje se nalaze u relevantnim naučnim bazama podataka, objavljena knjiga, originalni stručni uspjeh kao što je projekt, patent ili originalni metod te uspješno mentorstvo najmanje jednog kandidata za stepen drugog ciklusa studija odnosno integrisanog ciklusa studija". Iz prijave je vidljivo da je kandidatkinja konkursala za prijevremeno napredovanje u akademsko zvanje vanrednog profesora. Prema navedenom Zakonu, član akademskog osoblja u zvanju docent može biti izabran u više zvanje i prije isteka perioda u koji je biran "ukoliko ispuni uslove za izbor u više akademsko zvanje i ukoliko je proveo u nastavi najmanje tri godine nakon posljednjeg izbora te ukoliko je od propisanih radova za izbor u više zvanje za vanrednog profesora dodatno objavio najmanje tri naučna rada u citatnim bazama podataka".

According to the Law on Higher Education of the Sarajevo Canton, the conditions for selection to the position of associate professor are: "at least one election period as an assistant professor, at least five scientific works published in recognized publications that are in the relevant scientific

databases, a published book, original professional success such as a project, patent or original method and successful mentoring of at least one candidate for the degree of the second cycle of studies, i.e. integrated cycle of studies". It is evident from the application that the candidate applied for early promotion to the academic title of associate professor. According to the mentioned Law, a member of the academic staff in the title of assistant professor can be elected to a higher title even before the end of the period in which he was elected "if s/he meets the requirements for election to a higher academic title and if s/he has spent at least three years in teaching after the last election and if s/he has of prescribed papers for selection to a higher title for associate professor additionally published at least three scientific papers in citation databases".

Uvidom u prijavu, evidentno je da je dr. sci. Kazić-Çakar, u pogledu uslova za (prijevremenij) izbor u zvanje vanrednog profesora ispunila sve navedene uslove za izbor u zvanje vanrednog profesora, te dodatne uslove koji su uslov za prijevremeni izbor (uz ispunjene uslove za izbor u vanrednog profesora, provedene tri godine u nastavi, u zvanju docenta i najmanje tri dodatna naučna rada objavljena u priznatim publikacijama koje se nalaze u relevantnim naučnim bazama podataka), uvezši u obzir da je u proteklom periodu od izbora u zvanje docenta (četiri godine), objavila dvije knjige, deset naučnih radova objavljenih u relevantnim bazama podataka (naučni članci i poglavlja u knjigama), učestvovala kao koordinator, odnosno istraživač u dva naučnoistraživačka projekta, te ostvarila šest uspješno okončanih mentorstava.

Upon inspection of the application, it is evident that dr. sci Kazić-Çakar, regarding the conditions for an (early) election to the title of associate professor, fulfilled all the stated conditions for election to the title of associate professor, and additional conditions that are a condition for early election (in addition to fulfilling the conditions for election to the title of associate professor, spent three years teaching, in the title of assistant professor and at least three additional scientific papers published in recognized publications found in the relevant scientific databases), taking into account that in the past period since the election to the title of assistant professor (four years ago), she published two books, ten scientific papers published in relevant databases (scientific articles and book chapters), participated as a coordinator or researcher in two scientific research projects, and achieved six successfully completed mentorships.


