Pursuant the Article 121 of the Law on Higher Education ("Official Gazette of Sarajevo Canton", No.: 36/22), Article 177 of the Statute of IUS, No.: IUS-SENAT-11-1980/18 and Proposal of the Faculty Council, No.: IUS-FLW-15-2985/22 of November 1st, 2022, upon the consent provided by the Senate of the International University of Sarajevo, No.: IUS-SENAT-11-3225/22 of December 1st, 2022, the Faculty of Law published the announcement for appointment of one professor (assistant professor) for the scientific area of "Civil Law".

1. BIOGRAPHICAL INFORMATION AND ACADEMIC DEGREE OF THE CANDIDATE BIOGRAFSKI PODACI I PODACI O NAUČNOM STEPENU KANDIDATA

Dr. Sci. Khaled Mohammad Mustafa Khwaileh was born in Al Ramtha, Hashemite Kingdom of Jordan on October 14th, 1978. He completed his undergraduate studies in Law (Bachelor of Law), School of Law, Irbid National University, Jordan in 2002. Then, he graduated in Law in 2013 at Canberra Law School, University of Canberra, Australia. After that, he completed his master's degree in Law at Canberra Law School, University of Canberra, Australia in 2015. He completed his doctoral studies in 2020 at Macquarie Law School, Macquarie University Sydney, Australia in International Trade Law on the topic: "Jordan's International trading regime and integration with the Arab Region through trade liberalisation". He has been working as an assistant professor at Irbid National University since 2021. Likewise, he continued his professional work as a recognized lawyer, and also he worked in the legal department of Jordan Ahli Bank. He is a member of several professional organizations, such as the Society of International Economic Law (SIEL), the Australian

and New Zealand Society of International Law (ANZSIL) and the National Bar Association, Jordan. He has published several scientific articles in recognized publications. He is skilled in work on a computer and he speaks English language.

Svoj doktorski studij je završio 2020. godine na Macquarie Law School, Macquarie University Sydney, Australia iz Međunarodnog trgovačkog prava na temu: „Jordan's International trading regime and integration with the Arab Region through trade liberalisation“. Radio je kao docent na Irbid National University od 2021. godine. Isto tako, svoj rad u struci nastavio je kao priznati advokat, a i radio je u pravnom odjelu Jordan Ahli Bank. PROPOSAL AND RATIONALE PRIJEDLOG I OBRAZLOŽENJE

The Committee has thoroughly reviewed and considered the application submitted within public vacancy call, published on December 3rd, 2022 by the Faculty of Law in the newspaper "Nezavisne novine", on the web page of IUS and on the web page of the Faculty, and established that Dr. Sci. Khaled Mohammad Mustafa Khwaileh met the public call conditions for an appointment to scientific-teaching title of assistant professor from the Law on Higher Education ("Official Gazette of Sarajevo Canton", No.: 36/22). The Committee had the task to propose one candidate for appointment based on the assessment of the scientific work and publications.

Komisija je detaljno pregledala i razmotrila aplikaciju po prijavi na javni konkurs, objavljen dana 3.12.2022. godine od strane Pravnog fakulteta u dnevnom listu "Nezavisne novine", na web stranici IUS-a i Fakulteta, te je utvrdila da je Dr. Sci. Khaled Mohammad Mustafa Khwaileh ispunio uslove iz navedenog konkursa za imenovanje u nastavno-naučno zvanje docent shodno Zakonu o visokom obrazovanju ("Službene novine Kantona Sarajevo", broj: 36/22). Komisija je imala zadatak da predloži jednog kandidata za izbor u zvanje na osnovu procjene naučno-istraživačkog rada i publikacija.

According to the Law on Higher Education of the Sarajevo Canton, the conditions for selection to the position of assistant professor are: "scientific doctor's degree in the scientific field to which one is selected, a minimum of three scientific papers published in recognized publications, of which one scientific paper is published in a publication that is in the relevant scientific databases".

Prema Zakonu o visokom obrazovanju Kantona Sarajevo, uslovi za izbor u zvanje docenta su: "naučni stepen doktora u naučnoj oblasti na koju se bira, minimalno tri naučna rada objavljena u priznatim publikacijama, od čega je jedan naučni rad objavljen u publikaciji koja je u relevantnim naučnim bazama podataka".

Upon inspection of the application, it is evident that Dr. Sci. Khaled Mohammad Mustafa Khwaileh fulfilled all the stated conditions for selection to the scientific-teaching position of assistant professor, especially if we consider that the nominated candidate has previous experience in

teaching, that he has dealt with commercial law and that he has shown a particular interest in commercial arbitration.




